Introduction



Master Plan Update

Coleman Memorial Park, a 99-acre multi-use community park offering both active and passive recreation facilities, is located in the northwest corner of the City of Lebanon, Lebanon County, PA.

The park - formerly known as "Mt. Lebanon" and home to the estates of the Coleman and Brock families - was established in 1935 as a gift to the City of Lebanon "...for use as a public park that when improved will afford the citizens of the community a place of rest, recreation, entertainment and one of the finest natural parks in the country..."

The City of Lebanon's Office of Community and Economic Development is updating the Coleman Park Master Plan. To assist with the master plan update, the City has retained Simone Collins Landscape Architecture of Norristown, PA, who completed a master plan for Coleman Memorial Park in 2011. Since then, some park features have been removed and several of the master plan recommendations have been implemented. The master plan update is an opportunity for residents to work with the City to plan future park improvements that will be enjoyed for many years.

Project Goals

The master plan update is a guide for the future development and renovation of Coleman Memorial Park. The project Steering Committee, comprised of the City of Lebanon Community and Economic Development Office, City Council Members, and Coleman Memorial Park Board of Trustees, along with community input gathered from a public survey, have identified the following as goals for the master plan update:

- Incorporate improvements made in the park over the last 12 years since the 2011 master plan
- Simplify and clarify all signage and visitor wayfinding
- Create better pedestrian access within the park with improved/ additional walking paths
- Plan for new facilities based on public input, including but not limited to a dog park and an additional pavilion and restroom

Planning Process

This master plan update is an initial step towards improvement, presenting a consensus on desirable facilities and features for Coleman Memorial Park. The update provides estimates of probable costs of development, outlines a strategy for phasing improvements, and positions the City of Lebanon to pursue funding from a variety of potential sources. The update is a flexible guidance document; a blueprint that can adapt to the future needs of the community.

The next step is to identify and acquire funding for improvements. Once funding is obtained, detailed design and engineering can begin. Construction documents will be publicly bid, and a contract awarded for construction. Park improvements will be implemented through a series of phases, dependent upon funding, over a period of years.

Consultant

Simone Collins Landscape Architecture (SC) is a planning and design firm based in Norristown, Pennsylvania with expertise in parks, trails, greenways, and recreational facility planning. SC served as prime consultant for the 2011 master plan and 2023 update and was responsible for the overall facility design, public participation, and coordination with the City of Lebanon Community and Economic Development Office and Project Team.

Public Participation Summary

Public participation is an important part of any master plan or master plan update and helps to ensure the success of the project. Public participation lends credence to the need for this update and, ultimately, justification for support and implementation of its recommendations.

The consultants worked with the Steering Committee to tailor the public participation process to the project. The months long process provided the team with access to citizens' observations, needs, and ideas for the park and critical feedback on potential future park features and plans.

The process for this plan included one (1) public meeting and an online public opinion survey that was posted and advertised on the City of Lebanon website and affiliated social media accounts to gather additional public input. It was important for the project team to learn about citizens' observations, needs, and visions, and to incorporate what was learned into the master plan update.

Public Meeting Summary

The Public Meeting was held at the City Hall in the City of Lebanon in a hybrid format (in person/virtual option). The public meeting introduced the project, Committee, and consultant team. The team explained the importance of planning; reviewed the project schedule, public participation process, and the project scope; and presented information regarding existing conditions and facilities of the site. The consultant team then facilitated a brainstorming session, during which members of the public offered information about the site and ideas for moving forward. This information was organized into four categories: goals, facts, concepts, and partners. Major themes that resulted from this meeting include:

- Public satisfaction with the nature trail, bike trail, and bike pump track installed in the last 5 years and the Union Canal Tunnel Park trail connection and disc golf course to be built (2023-2024)
- Public interest in a future skate park, community garden, nature center and associated programming, nature/ plant ID signage, and pool replacement, like a splash pad

- Improvements for better signage, better trail markers, adding trash cans, removing or repurposing the old gate where Donough Drive meets 20th Street, and more ADA parking
- Future volunteering opportunities with Friends of Coleman Park

The notes for this meeting can be found in the appendix of this report.

Data Collection & Methodology

The consultants performed an initial field reconnaissance in January 2023 to inventory and document existing conditions of the park. Subsequent field visits were completed over the next few months. Site photographs, measurements, and field observations gathered during site visits were valuable throughout the project process.

Base plan data was compiled using the following available information: Geographic Information System (GIS) mapping from the City of Lebanon; PA Map project aerial photography and 2 foot contour information from the Pennsylvania Spatial Data Access (PASDA) website; and utilities information from the City of Lebanon Authority and the Coleman Memorial Park Caretaker Craig Henninger.

Inventory & Analysis

Site Description

Location

Coleman Memorial Park is located in the City of Lebanon, the county seat of Lebanon County, Pennsylvania. It is adjacent to the following municipalities: North Lebanon to the north, South Lebanon to the east, North Cornwall to the southwest, and West Lebanon to the west. The City occupies about 4.17 square miles of land and is located about 61 miles southwest of Allentown, 26 miles east of Harrisburg, and 88 miles northwest of Philadelphia. The park is located in the northwest corner of the city and is accessible via Route 72/ West Maple Street, which also bounds the north side of the park. The park is not easily accessible to pedestrians that are not coming from the residential developments to the southwest of the park. For most park visitors, driving via Route 72 is the easiest way to get to the park.




Figure 2.1 Regional Context Map

History / Historic features

Note: Text for the Park History and Coleman Family in this chapter was authored by Jim Polczynski, member of the Steering Committee and the Friends of Coleman Memorial Park.)

Not far from the Union Canal, brothers George Dawson and Robert Coleman, built two hot-blast anthracite furnaces in the north-west corner of Lebanon, the first such furnaces in Lebanon County, in the 1840s. In 1852, Robert sold his interests in the furnaces to George Dawson. By 1853 George Dawson built the first mansion in what is now Coleman Memorial Park. This was a grand estate with stables, farms, an ice-house, a gate house and other related out-buildings. The mansion was torn down in 1961 and in the history of the Colemans the mansion is called the "Homestead". George Dawson married Deborah Brown of Philadelphia in 1852 and as their children grew and married, the estate was parceled off to accommodate the children.

The other mansions were built for Sarah and Arthur Brock, Debbie and Horace Brock, Bertram Dawson Coleman and John Penn Brock. All of these properties were deeded to or sold to the City of Lebanon beginning in 1936 and Coleman Memorial Park was created. Today the "Homestead" stables, known as the Carriage House, stands in the center of the park. The "Homestead" gate house greets visitors to the park and the gate house for the Horace Brock mansion bids farewell to visitors as they exit the park. The Ready House stands to the north of where the "Homestead" stood.

Other remains are visible in the park, including the garden area of the John Penn Brock mansion. Also, along the south end of the park are remains from the furnace operations - the large stone wall on the right as you exit the park are the remains of a vanity wall constructed to shield the Horace Brock mansion from the operations of the furnaces.

Later deeds and sales to the City added to the park's land, including the Arthur Brock Extension to Coleman Memorial Park - materials from the Arthur and Sarah Brock mansion were used to construct the original Bandshell. There was no trust included with the gifts and thus it became the City's responsibility to fund ongoing operations in the park. The gift did include a statement from the family that, while the City of Lebanon was under no obligation to do so, the family suggested that the creation of a "museum for the preservation of colonial handicraft arts and a historical museum and library, and the use of the buildings to foster music, the drama, and handicrafts, are to be understood to be clearly within the purpose of the gift."

The day-to-day decisions for the park are the responsibility of a Board of Trustees. It is interesting to note that the streets in the park are named for the early Board members. Sarah Brock wished the Arthur Brock mansion demolished and in 1937 this work was completed under a work order from the WPA. The other mansions were gradually razed due to lack of funds to properly maintain the upkeep on the buildings until the last mansion, the "Homestead" was razed in 1961. During demolition the contractors got quite a surprise - they found the locally famous "Lincoln" letter written by Abraham Lincoln to George Dawson Coleman appointing Coleman to represent the United Sates to the Industry of All Nations exhibition to be held in London. This letter was discovered in a "hidden" office whose access was from a false bookcase.

The swimming pool was added in 1940 and renovated at a substantial cost in the 1980s. The Gazebo located adjacent to the Children's Garden was donated by Coleman descendant LeRoy Holman in memory of his mother, Harriet Dawson Coleman Glover. This was donated consistent with a Coleman Family reunion in May of 1994. Also beginning at the start of the 1990s is the very successful Music in the Park program. 2010 marked the 20th Anniversary of Music in the Park and 2011 marks the 75th Anniversary of the establishment of Coleman Memorial Park.

Coleman Family

George Dawson Coleman and his brother Robert built the North Lebanon Furnaces in the 1840s. They were the grandsons of Robert Coleman - the Robert Coleman that purchased Elizabeth and Cornwall Furnaces. This Robert Coleman was Pennsylvania's first millionaire of record. His grandsons exhibited the same bold industrial leadership by constructing Lebanon County's first hot-blast anthracite iron furnace when they were only in their 20s.

George Dawson Coleman was considered one of the finest Iron Masters of his day. He married Deborah Brown of Philadelphia in 1852, the same year he purchased his brothers interest in the North Lebanon Furnaces. They constructed the "Homestead" estate just north of the furnaces. George Dawson Coleman was very generous to the Lebanon Community and was acquainted with President Abraham Lincoln and a personal friend of President U. S. Grant. George Dawson Coleman remained active in the furnace operations until his early death in 1878, at the age of 53. His two youngest sons were only in their teens at the time and not able to take over the management of the operations. Fortunately, his sons-in-laws, Arthur and Horace Brock were more than capable to assist Deborah Brown Coleman in the task.

Horace and Arthur Brock were sons of John Penn Brock, a wealthy coal operator, among other activities. Both sons had a keen business sense with industrial interests. They married daughters of George Dawson and Deborah Brown Coleman – Arthur married Sarah and Horace married Debbie. It is interesting that the Brock brothers and the Coleman daughters were actually distant cousins. The Brocks managed the furnace operations for Deborah Coleman after her husband's passing until Bertram Dawson and Edward Coleman were of age to assume the management of the furnaces. Horace and Arthur became involved in numerous mining operations in the American South West as well as in local Lebanon manufacturing resulting at the end of the 1890s in the formation of the American Iron and Steel Corporation – the merger of numerous companies in Lebanon and ReadinG. One of the early decisions that Bertram Dawson and his brother Edward made was to sell the North Lebanon Furnaces to Pennsylvania Steel in 1901. Bertram stayed on as manager. The Coleman and Brock families were a close

knit family that enjoyed each other's company immensely and they gave many grand and elegant parties at Mt. Lebanon (as the estate was then known).

By the end of the 1920s many considerable changes happened within the family and their business. Horace and Arthur Brock had passed away and Bethlehem Steel had come to town and purchased, among other companies, Pennsylvania Steel and Lackawanna Steel. They took possession of the North Lebanon Furnaces and the manufacturing facilities of American Iron and Steel. Horace and Debbie's son John Penn Brock (named for his grandfather) became a manager in the Bethlehem Steel company, but sadly passed away at a young age in 1928. This was followed by the passing of Bertram Dawson in 1933 and finally in 1935, the last Coleman living at Mt. Lebanon, George Dawson and Deborah's daughter Fanny, passed away. The descendents either sold or gifted their estates to the City of Lebanon forming the genesis of what is now Coleman Memorial Park. The Coleman name is still a name that engenders awe and respect in the Lebanon community and their legacy is a powerful and inspiring testimony to the history and development of our community.



Park Formation – Deed of Gift

The purpose of the Deed of Gift was expressed to Lebanon City Council as follows:

"for public use as a public park that when improved will afford the citizens of the community a place of rest, recreation, entertainment and one of the finest natural parks in the country, the fine residences and other buildings thereon will provide for housing of gifts of paintings and handicrafts... the entire estate will be perpetually held intact as a public park for the citizens of the City of Lebanon..."

The Deed of Gift was conditioned upon the following:

- 1. That the City of Lebanon would provide funds for development, maintenance, lighting and policing of the Park, and would employ a Park Superintendent or Caretakers.
- 2. The governing body for the Park would be the Board of Trustees, members of whom are to be appointed by the Lebanon County Court of Common Pleas.
- 3. The Trustees would make recommendations to the City of Lebanon and would otherwise be responsible to establish rules and regulations for governing the Park, and for its development and activities.
- 4. Should the City of Lebanon fail to provide "funds sufficient for the purpose of said gift, or if the use of the premises conveyed for said purpose is discontinued," then the Park lands would revert back to the donors.

In conjunction with acceptance of the Deed of Gift, the City of Lebanon entered into a Agreement dated December 31, 1935, which sets forth a few more pertinent provisions:

- 1. The Board of Trustees was authorized to "adopt a plan for the improvement and maintenance of said Coleman Memorial Park."
- 2. "All plans and expenditures for improvement and maintenance of the [Park] shall be under their [Trustees] contract, subject to such appropriation as [Lebanon City} Council may, from time to time, make as aforesaid."
- 3. The Board of Trustees is empowered to appoint superintendents, caretakers and others, and prescribe their compensation.
- 4. The Board of Trustees is required to provide an annual budget and report to Lebanon's Mayor and City Council in November of each year.
- 5. The Board of Trustees is empowered to accept, "in the name and behalf of the City of Lebanon, devises, bequests and donations of monies, objects of art and natural history, maps and books" so long as they are compatible with the purposes set forth in the Deed of Gift.
- 6. "That the said Board of Trustees shall have the power to govern, manage, lay out, plan and ornament the said Coleman Memorial Park, and maintain the same in good order and repair, and to construct, maintain and repair all buildings within the limits of said Coleman Memorial Park, subject to such appropriations as Council may, from time to time, make..."
- 7. In addition to the power of the Board of Trustees to promulgate rules and regulations governing the Park, the City of Lebanon was also empowered to enact ordinances to enforce those rules and regulations.
- 8. The City of Lebanon agreed to "from time to time, make appropriations from its funds to said Board of Trustees to carry out the terms and provisions of this contract and such appropriations as are reasonably necessary to establish and maintain the said Coleman Memorial Park, in accordance with the terns of said Deed of Gift."

Topography description

Coleman Memorial Park sits atop the landform locally known as 'Mt. Lebanon' – the highest point in the City of Lebanon. A ridge line runs through the center of the park from the Exit House and Furnace Hill Road in the east to the J. P. Brock mansion site and pavilion #5 in the west. The G. Dawson Coleman "Homestead" mansion site sits just to the east of the park's highest point of elevation, a comparatively flat area contained within Frick and Bashore Drives. The majority of park related facilities are located to the south of this east-west ridge line to take advantage of the south facing slope. North of the ridge line is mostly wooded with few facilities except for portions of the shared use trail, nature trail and disc golf course. Many of the existing park facilities are located on level areas that were created by the former mansion sites. Another relatively flat section of the park is the former pool location to the south of Bashore Drive and the east of the bike pump track. The ball fields are in the southwestern portion of the park where level areas were carved out for their original construction. Otherwise, existing slopes provide challenges to providing universal ADA Access for park facilities as the majority of existing slopes exceed 5%. While there are some man-made slopes exceeding 20% resulting from the development of park facilities, the majority of the park's steepest slopes (>20%) are located north of the ridge line.

Zoning & Surrounding Land Use

The park site is zoned as Municipal Recreation and is surrounded by a mix of different zoning types, primarily residential. Within the City of Lebanon, Coleman Memorial Park is neighbored by Light Industrial Commercial, General Commercial and High and Medium Density Residential. From North Lebanon Township, the park is surrounded by Medium and High Density Residential, Agriculture, Municipal Recreation (the connection to Union Canal Tunnel Park), and Industrial and General Commercial. From West Lebanon Township, the park is adjacent to Low Residential and Industrial. 


Figure 2.2 City of Lebanon Zoning Map Credit: Urban Research & Development Corporation



Geology/ Soil


The site is in the Ridge and Valley Province of Pennsylvania. The region consists of elongated parallel ridges and valleys that are underlain by folded Paleozoic sedimentary rocks. Within the province, the park is within the Great Valley Section, which is a continuous basin spanning the eastern side of the province. Within the Great Valley Section, the park has rocks that are a part of the Hamburg sequence, which is predominantly made up of shale and siltstone. Coleman Memorial Park is comprised of three primary soil types: Bedington shaly silt loam (Be), Berks shaly silt loam (Bk), and Weikert shaly silt loam (We) with slope classifications B (3-8%), C (8-15%), and D (15-25%) as per the USDA Soil Conservation Service Soil Survey of Lebanon County, PA. Each of these soils are classified as 'moderate' for recreational development, meaning that limitations may be overcome or alleviated by planning, design, or special maintenance. The primary limiting factors of these three soil types are slope, small stones, and depth to bedrock (Weikert soils only). The soils associated with the ball fields are classified as Urban Land meaning that these soils are not naturally occurring and were imported for the construction of the fields.



Hydrology

Coleman Memorial Park is in the Susquehanna River Basin, within which the park is in the Quittapahilla Creek Major watershed. There are no water bodies within the park and no significant signs of erosion on site. The site generally drains from either side of the highest ridge that runs from the Exit House to J.P. Brock Mansion site. There is a significant swale that runs from the northwest corner to the southwest corner that drains to the Quittapahilla watershed, and another smaller swale that runs from the location of pavilion #1 to the park entrance. Vegetation

The Coleman Family planted many rare and beautiful specimens of trees and shrubs, many of which remain in Coleman Memorial Park today. Approximately 50-60% of the park is a wooded cultural landscape which is an environment altered by man and filled with introduced plant species, some of which are exotic and/or invasive. The Lebanon County Champion of Ginkgo, Blackgum and Katsura Trees were all found within the park at one time, including some of the oldest and largest oak trees found in Pennsylvania. Also found in Coleman Memorial Park is the European Purple Beech, Umbrella Magnolia, Chinese Toon, the Bottlebrush Buckeye, and Paulownia. The park has a 1.6-mile Nature Trail that circles the park and passes many of these historic and unique trees.

Invasive plant species and some of the older trees will need to be addressed to maintain the park's quality of the natural environment. These plant species and communities within the vegetated areas also offer the park an excellent opportunity for not only nature enthusiasts for activities such as plant identification and bird watching, but also the development of environmental education programs that could be utilized by the local schools as an outdoor classroom learning experience.

Vehicular Site Access & Parking

There are four (4) designated off-street parking areas located within Coleman Memorial Park.

The largest of the four parking areas is located to the east of the Carriage House measuring approximately 65,000 square feet with the capacity for nearly 200 cars. This was once the main parking area for pool users and the mini golf course (both facilities of which are now removed from the park). This lot is fairly level with random tree wells combined with striped parking stalls that do not appear to follow any particular hierarchy, resulting in an open and somewhat confusing layout, especially for first-time users. The far eastern end of the parking lot is the site of the former Horace Brock mansion.

The second largest lot is located in the southwestern end of the park nearest the amphitheater and ballfields. This 45,000 square foot lot (approximately 66 spaces, including 4 ADA) consists of 3 parking bays that allow for a level parking surface and opportunities for stormwater infiltration within the parking islands. Planting within these islands are limited to trees at the ends of the parking islands, interspersed shrubs in between, and lawn.

Another smaller parking lot is located just above the main amphitheater parking lot. This 8,200 SF lot that is fairly level and has approximately 30 spaces.

There is also an approximately 9,500 SF pervious lot on Frick Drive with 37 spots that that provides the most direct access to the playground.

The last off-street parking lot at approximately 8,000 SF is located just to the south of the Ready House nearest the G. Dawson Coleman 'Homestead' mansion site. This lot has approximately 36 spaces, 2 of which are ADA.

Other informal poorly defined off-street parking areas are located along the park roadways that provide access to park pavilions. This leads to inefficient use of the spaces provided and increased maintenance requirements. During concert events, all available space within the vicinity of the amphitheater is utilized for parking wherever possible, including spots within lawn areas along the roadways. This, too, leads to increased maintenance requirements in a park where maintenance resources are limited.

Utilities

Information regarding the existing utilities found within Coleman Memorial Park was provided by the City of Lebanon Authority.

Water service is provided to park facilities from a water main line paralleling PA Route 72 along the park's northern boundary. Water service is provided at all the restrooms, the Carriage House and the Caretaker's house, and to the southeastern most ballfield. A water line is also present where the former pool used to be, and may be used in the future to provide water at the proposed dog park. The only building on the property connected to the public sewer is the concession adjacent to the bike pump track. All other park facilities with restrooms have on-site septic systems and are not tied into a public sanitary sewer system. Storm water drainage facilities and conveyance systems are evident in some locations, noticeably missing in others - primarily with the two large parking lots at the Carriage House and amphitheater/ball fields, and overall throughout the site and are not mapped. Electric service is provided to all park facilities from multiple sources.

PNDI Survey results

A Pennsylvania Natural Diversity Inventory (PNDI) Survey was applied for Coleman Memorial Park and it was determined that there are no species of concerns on the site. The survey is located in the appendix.

Existing Structures & Buildings Inventory

Of the park's many structures, many are associated with the Coleman Family estates, which provides many opportunities to celebrate and share the history of these sites. The historical structures and remnants include, from west to east:

- The J.P. Brock Mansion Pergola
- The Carriage House, now serving as a maintenance building
- The Ready House, now serving as a maintenance building with a meeting room
- The Vanity Wall, a remnant of the wall that was constructed to shield the Horace Brock Mansion from the operations of the furnaces.

Other buildings on site include the caretaker's house and outbuilding, 3 stand-alone restrooms, the amphitheater, the band shell, the bike pump track concession/ restroom, the Exit House and Exit House garage, and a shed and concession/ restroom building in the former minigolf area.

The park also has one gazebo and six pavilions. The pavilion reservation records indicate that the pavilions are some of the most highly used facilities in the park, especially on weekends. Some are older and in need of repair or replacement, such as pavilion #2 between Kreider and Frick Drives. The newest pavilion is at the bike pump track, now one of the most sought after pavilions for reservation within the park. The largest pavilion, called the Band Shell, is located between Frick and Bashore Drives across from the bike pump track. Currently there is no existing path or ADA access to the Band Shell, and there are only two parking spots in its proximity along Bashore Drive.

Park Facilities

Other park facilities and features include: a playground constructed in the last 5 years, which is adjacent to the Children's Garden Gazebo, two tennis locations, each with two courts, two basketball courts, recently expanded and repaved, two baseball

fields and two little league fields, amphitheater seating, steps and terraces from the former garden at the J.P. Brock Pavilion, and a sculpture by Lorri Acott titled "Conversation with Myself", which was dedicated in 2020 to the students of Lebanon.



Regional Context

Access to parks and trails

The nearest regional trail to Coleman Memorial Park is the Lebanon Valley Rail Trail, an 18-mile trail that has a segment through Union Canal Tunnel Park, a quarter mile to the west of Coleman Memorial Park. A future phase of the Rail Trail will connect the Union Canal Tunnel segment to the segment that runs from US-422 in the City of Lebanon south to Bellaire, PA. The Union Canal Tunnel Park Trail connection from Coleman Memorial Park allows park visitors to access both parks and the Rail Trail, which allows for hiking, cycling, horseback riding and cross-country skiing. 
Part of the recommendations in the Comprehensive Plan for Lebanon County (2007) includes a regional greenways and trails map (Figure 2.3). The map shows the Lebanon Valley Rail Trail as well as two proposed regional greenways running east-west through the City of Lebanon: the northern-most proposed Union Canal Connector running through Coleman Memorial Park, and the proposed Quittapahilla Creek Greenway to the south. Part of the proposed Union Canal Connector is the trail linking Coleman Memorial Park and Union Canal Tunnel Park (construction completed in 2023-2024). If trails through the Union Canal Connector Greenway are expanded and if trails in the Quittapahilla Creek Greenway are developed, these trails would provide valuable regional links to Coleman Memorial Park in addition to the Lebanon Valley Rail Trail.




Figure 2.4 DCNR '10-Minute Walk Access' Map for the City of Lebanon

When considering people's access to parks, the DCNR '10-Minute Walk' map (Figure 2.4) shows what percentage of a city/ township's population has a 10-minute or less walk to a park/ public open space. In the vicinity of Coleman Memorial Park,



the percentage of residents that have a 10-minute walk or less to a park are 93% for the City of Lebanon, 45% for North Lebanon Township, and 89% for West Lebanon Township. The map indicates that there needs to be greater access to parks for the northern section of the City of Lebanon and southern section of North Lebanon Township. STRAVA Bike and Run Heat Maps

STRAVA is a popular application which utilizes GPS tracking to record routes used by walkers, runners and cyclists. STRAVA heat mapping was used to locate popular routes within and around Coleman Memorial Park. This mapping shows in red the highest used routes in the area and therefore provides insight into the most well-traveled and potentially safest routes for future pedestrian and bicycle improvements.

Within the park, it is evident that the shared use trail is the most popular for bike users, followed by roads within the park. For runners, a majority of people run along the roads within the park, which could indicate a need for trails that are separate from the road.

Both of these maps, generated before the construction of the Union Canal Tunnel Park trail connection to Coleman Memorial Park, show that the primary connection for runners and cyclists is from the east at Furnace Hill Road, followed by the park's main entrance which is further northbound up Route 72. The trail connection to Union Canal Tunnel Park will provide another access point from the west. However, the maps indicate that there is a need for improved access to the park from the north from 20th Street and from the adjacent neighborhood to the south.

Coleman Memorial Park Master Site Plan Update

Demographics

Coleman Memorial Park, though it falls within the City of Lebanon, borders North Lebanon and West Lebanon Townships. Figure 2.5 compares United States Census Bureau population data for these townships and the county from 2010 and 2020

While the population of West Lebanon has remained steady, as it is primarily zoned for manufacturing and commercial, the City of Lebanon, North Lebanon, and Lebanon County as a whole have experienced population growth from 2010 to 2020 and is expected to continue to grow in the future. Coleman Memorial Park will continue to serve as a facility to provide for the recreational needs of the Lebanon area, and with the growth rates expected for the County as a whole, continuing the operations and availability of this park is very important towards maintaining the regional parks and recreation public infrastructure.

Pennsylvania Statewide Comprehensive Outdoor Recreation Plan: Recreation for All, 2020-2024

The goal of the Comprehensive Outdoor Recreation Plan is to help all Pennsylvania residents achieve greater access and enjoyment from experiences in Pennsylvania's local and state parks, state and national forests, trails, rivers, lakes, game lands, and other recreation spaces. It serves as a guide for local and state governments and other recreational providers, including DCNR, to identify areas of greatest need, set priorities for state and federal grant funding, and delineate a course of action. The five priorities areas that capture the current challenges and opportunities for outdoor recreation in Pennsylvania are: Health and Wellness, Recreation for All, Sustainable Systems, Funding and Economic Development, and Technology.

Opportunities and Constraints

The following are opportunities and constraints as they pertain to the existing park. Recommendations are made in Chapter 4.

Opportunities

Historical Elements – The Coleman family legacy provides an excellent opportunity for historical interpretation and creation of an overall theme to guide future development or facility upgrades.

Natural Setting – The beautiful natural setting created by the parks flora and fauna intermingled with the park facilities provides great respite for park users and the opportunity for a wide range of passive recreation, environmental education programs and activities, and sustainable stormwater design solutions.

Popular Park – Coleman Memorial Park is very popular and well used by local residents and outside visitors alike. The wide range of both active and passive recreation activities provides by the park offer recreational opportunities for all ages. Park improvements will only enhance the experience for park users.

<u>Constraints</u>

Access and Circulation – Coleman Memorial Park is on a hill at the edge of the city and does not have the same ease of access as other city parks. As the entry from PA Route 72 is the only public access into the park, there is a need for better pedestrian access to and from the adjacent residential communities. Additionally, the internal areas of the park are in need of better wayfinding as well as defined spaces between pedestrian and vehicular uses.

Existing Utilities – The current condition of the parks' utilities will need to be upgraded to provide adequate service once improvements are made.


Maintenance Requirements – Many of the current facilities require additional maintenance measures that would not be necessary with modern design solutions. This applies mostly to the parks' circulation and parking areas. Given the limited amount of resources available for maintenance, these requirements should be considered in the design process as park facilities are upgraded over time.





Public Opinion Survey Results



Which parks in and around Lebanon City do you occasionally or regularly visit?



Which other area parks and open space do you occasionally or regularly visit?



Community Needs, Uses and Priorities

Public Consensus

From the Committee and input from the public meeting and public survey, the following were identified as community needs, uses and priorities for Coleman Memorial Park:

- Simplify and clarify all signage and visitor wayfinding, from roads, walkways and trails
- New pavilion and restrooms between basketball courts and John Penn Brock Gardens and pergola
- Increase walking paths that are separate from the roads
- Dog park at the former pool location with ADA access
- Parallel parking on Bashore Drive to serve the dog park
- Nature/ plant signage
- Trash cans throughout park

Anticipated Levels of Use

On a daily basis, depending on the season and weather, Coleman Memorial Park is anticipated to receive moderate use as one of the more popular parks within the City of Lebanon. Primary users of the park facilities will likely be nearby residents of the city, North Lebanon and West Lebanon. It is anticipated that most visitors will drive to the park. Some of the most popular events and activities include the baseball tournaments, basketball tournament, tennis camp, July 4th fireworks, 'United Way Day of Caring' volunteer event, an 'Envirothon' for middle school students, an annual car show, 'Music in the Park' series, and the Christkindl Market. Thousands of people come to some of these events, including the baseball tournaments, 'Music in the Park' and the fireworks.

Design Guidelines

Uniform Construction Code

Pennsylvania's statewide building code is referred to as Uniform Construction Code (UCC). Enforcement of the UCC began in April 2004. Since then, over 90% of Pennsylvania's 2,562 municipalities, including the City of Lebanon, administer and enforce this code locally. The UCC includes various industry building standards including the International Building Code (IBC). American Society for Testing Materials (ASTM) standards

ASTM International, founded as the American Society for Testing and Materials, is a nonprofit organization that develops and publishes approximately 12,000 technical standards, covering the procedures for testing and classification of materials of every sort. ASTM standards are used for the basis of assuring construction materials and methods are sources and installed properly. Where applicable the development of Park infrastructure should comply with ASTM standards. Examples of such work include the placement of asphalt and concrete walkways.

Consumer Product Safety Commission (CPSC)

CPSC administers and enforces several federal laws. These laws authorize the agency to protect the public against unreasonable risks of injuries and deaths associated with consumer products. As such, the CPSC sets standards for safety on playgrounds. The development of playgrounds in the park should comply with all relevant CPSC codes.

Accessibility /Universal Design

The Americans with Disabilities Act (ADA) Standards for Accessible Design serve as a base line accommodation standard for building accessibility in the United States. These are standards mandated by Federal statute. Public recreation improvements must be designed following the most recent edition of the ADA Accessibility Guidelines for Buildings and Facilities. The most recent version of the ADA Accessibility Guidelines for Buildings and Facilities can be found at: http:// www.ada.gov. These standards will play a key role in the design of Coleman Memorial Park facilities to assure that universal access is achieved, and the facilities function for users of all abilities.

Additional guidelines have been developed to provide guidance for outdoor recreation facilities including trails. Coleman Memorial Park trails should be as inclusive as possible given the extensive area terrain. The following chart summarizes the various design criteria for accessible trails. The full guidelines can be found at: https://www.access-board.gov/aba/guides/ chapter-10-outdoor/#trails.

There are additional standards which exceed ADA. Universal Design (UD) is defined as "the design of products and environments to be usable by all people, to the greatest extent possible without the need for adaptation or specialized design" (Center for Universal Design, North Carolina State University). Universal design is meant to be adaptable to various building types, learning environments, and communities. UD is driven by seven core principles:

Equitable Use. The design is useful and marketable to people with diverse abilities. For example, a website that is designed to be accessible to everyone, including people who are blind and use screen reader technology, employs this principle.

Flexibility in Use. The design accommodates a wide range of individual preferences and abilities. An example is a museum that allows visitors to choose to read or listen to the description of the contents of a display case.

Simple and Intuitive. Use of the design is easy to understand,

regardless of the user's experience, knowledge, language skills, or current concentration level. Science lab equipment with clear and intuitive control buttons is an application of this principle.

Perceptible Information. The design communicates necessary information effectively to the user, regardless of ambient conditions or the user's sensory abilities. An example of this principle is captioned television programming projected in a noisy sports bar.

Tolerance for Error. The design minimizes hazards and the adverse consequences of accidental or unintended actions. An example of a product applying this principle is software applications that provide guidance when the user makes an inappropriate selection.

Low Physical Effort. The design can be used efficiently, comfortably and with minimum fatigue. Doors that open automatically for people with a wide variety of physical characteristics demonstrate the application of this principle.

Size and Space for Approach and Use. Appropriate size and space are provided for approach, reach, manipulation and use regardless of the user's body size, posture, or mobility. A flexible work area designed for use by employees who are left- or right-handed and have a variety of other physical characteristics and abilities is an example of applying this principle.

Summary of Relevant City Zoning and SALDO Ordinances

The following City of Lebanon zoning ordinances relate to Coleman Memorial Park.

Article 1307 – Design Standards and Guidelines and Design Review

§1307.03 Recommended Design Guidelines in all Districts

(c) Pedestrian safety and orientation.

(1) Pedestrian crosswalks should be provided along arterial

street corridors using materials and colors that visually distinguish the crosswalk from the street surface and that include some texture. A method should be used that is durable, instead of simply being adhered to the top of the asphalt.

(2) Pedestrian traffic should be separated from major vehicle routes. Developments should be designed in such a way as to be inviting for pedestrian traffic and to provide convenient walking routes from any public transit stops.

Article 1310 – Environmental Protection

§1382.315 Erosion Control

(a) All subdivision and land development plans which propose earthmoving activity shall include erosion and sediment pollution control design to satisfy the requirements of Chapter 102, Pennsylvania Department of Environmental Protection, 25 Pa. Code, Chapter 92 and/or 102, and the Pennsylvania Clean Streams Law (35 P.S. § 691.1 et seq.) and to prevent soil erosion, sediment and other pollutants from entering streams, lakes and neighboring properties. In order to demonstrate and maintain compliance with erosion and sediment pollution control requirements, subdividers and land developers shall:

- Prior to earthmoving or subdivision/land development plan approval, obtain erosion and sediment pollution control design approval from the Lebanon County Conservation District.
- (2) Obtain applicable NPDES approvals or permits through the Lebanon County Conservation District and the DEP and maintain plans and permits on site.
- (3) Install required erosion and sediment pollution control facilities prior to the start of construction and maintain said facilities during the construction period.
- (4) Preserve and protect natural vegetation where possible.
- (5) Adhere to approved erosion and sediment pollution control design requirements and NPDES standards.
- (6) Inspect weekly and after each runoff event and

maintain all erosion and sediment pollution control facilities to ensure their effectiveness. Accumulated sediment shall be promptly removed, and disturbed areas shall be reseeded or stabilized.

(7) Design, install and maintain facilities in accordance with the PADEP Erosion and Sediment Pollution Control Program Manual (E&S Manual),[1] Technical Guidance No. 363-2134-008 (March 2012), as amended.

> [1] Editor's Note: See Reference No. 2 in Division IX of this article.

- (8) Include standard erosion and sediment control notes on all plans, as per the list within the Appendix.
- (9) Be subject to penalties for noncompliance, in accordance with the provisions of Division VII of this article.
- (10) Construction of temporary roadways (for utility construction, timber harvesting, etc.) shall comply with all applicable standards for erosion and sedimentation control and stream crossing regulations under 25 Pa. Code, Chapters 102 and 105. The erosion and sedimentation control plan shall be submitted to the Lebanon County Conservation District for approval and shall address the following, as applicable:
 - A. Design of roadway systems, including all roads, skid roads, landing areas, trails, and storage and staging areas.
 - B. Runoff control structures (e.g., diversions, culverts, detention ponds, etc.).
 - C. Stream crossings for both perennial and intermittent streams.
 - D. Access to public roadways, including design of rock construction entrance for mud and debris control.
 - E. A remediation plan for restoring the disturbed area through regrading, topsoil placement, reseeding, and other stabilization techniques as required.

- (11) Additional erosion and sedimentation control design standards and criteria that must be applied where infiltration BMPs are proposed include the following:
 - A. Areas proposed for infiltration BMPs shall be protected from sedimentation and compaction during the construction phase, as to maintain their maximum infiltration capacity.
 - B. Infiltration BMPs shall be protected from receiving sediment-laden runoff.
 - C. The type of protection for infiltration BMPs shall be identified (i.e., orange construction fence surrounding the perimeter of the BMP).
- (12) Maintenance during development of a project shall be the responsibility of the developer and/or landowner and shall include, but not be limited to:
 - A. Removal of silt and debris from basins, traps, inlet protection, silt fencing, or other structures or measures when capacity of those structures is reached.
 - B. Periodic maintenance of temporary control facilities such as replacement of straw bale dikes, straw filters or similar measures.
 - C. Establishment or reestablishment of vegetation by seeding and mulching or sodding of scoured areas or areas where vegetation has not successfully been established.
 - D. Installation of necessary controls to correct unforeseen problems caused by storm events within design frequencies.
 - E. The contractor or developer shall be responsible for removal of all temporary measures and installation of permanent measures upon completion and stabilization of the project.
- (13) Total maximum daily load (TMDL) requirements.

- Agricultural activities contributory to a watershed within the City containing an established non-point-source (agriculture) TMDL shall be conducted in compliance with Chapter 102 (Erosion and Sediment Pollution Control); Chapter 91, Section 91.36 (General Provisions Related to Manure Management); and Act 38 (Nutrient Management).
- B. This section shall also apply to agricultural activities conducted in watersheds where TMDLs are established in the future.

Stormwater Management

Erosion & Sedimentation Control

As noted in the City of Lebanon, Erosion and Sedimentation Controls Plans are required by Pennsylvania Department of Environmental Protection (DEP) for projects that create more than 5,000 square feet of earth disturbance. The City of Lebanon is delegated by the DEP to conduct certain activities for the Erosion and Sediment Pollution Control (ESPC) program and the National Pollutant Discharge Elimination System (NPDES) program for stormwater discharges from construction activities in Lebanon County. Also, DEP Rules and Regulations state that a municipality or county which issues building or other permits shall notify the DEP within 5 days of receipt of an application for a permit involving an earth disturbance activity consisting of 1 acre or more. With the exception of local stormwater approvals and authorizations, a municipality or county may not issue a building or other permit or approval until an NPDES or E&S permit, if necessary, has been obtained from the DEP.

The National Pollutant Discharge Elimination System (NPDES) Permit

The overall goal of the NPDES permit is to improve water quality. It is a federal permit that is administered at the state level, the overall goal of the NPDES permit is to improve water quality. Projects that disturb over one (1) acre of land require an NPDES permit for Stormwater Discharges Associated with Construction Activities.

The permit plans are divided into two (2) parts. The Erosion

& Sedimentation Pollution Control plans (ESPC) are to be implemented by the contractor throughout construction activities until the site is stabilized by permanent plant growth. The Post Construction Stormwater Control Plans (PCSC) are to be constructed during the project and maintained by the site owner for the life of the project.

Stormwater Best Management Practices (BMPs)

The *Pennsylvania Handbook of Best Management Practices for Developing Areas*, developed by the Pennsylvania Department of Environmental Protection (PADEP), offers numerous solutions for handling on-site stormwater. Where feasible, BMPs should focus on vegetated/surface solutions to create opportunities that combine planting improvements with stormwater management and for education. BMPs that might be implemented at the Park include:

- Protect/utilize natural stormwater flow direction;
- Habitat restoration;
- Soil amendments;
- Native tree and shrub planting;
- Rain gardens;
- Bio-swales;
- Detention/infiltration facilities; and
- The use of porous surfaces in the parking areas or trails.

These facilities require site-specific soil tests to determine site suitability and the infiltration rates of the existing soils. Incorporation of these BMPs into park development will have a direct positive impact on preserving and enhancing water quality. The opportunity for education exists through the placement of interpretive signage to educate park visitors about watershed water quality and how BMPs can positively impact all sites.

Sustainable Site Design & Green Infrastructure

Stormwater Best Management Practices (BMPs)

Developed by the Pennsylvania Department of Environmental Protection (PA DEP), the Pennsylvania Handbook of Best Management Practices for Developing Areas offers numerous solutions for handling on-site stormwater. Where feasible, BMPs should focus on vegetated/surface solutions that combine planting improvements with stormwater management and create opportunities for education. Best Management Practices (BMPs) that might be implemented at the Park include:

- Protect and restore forest buffers;
- Protect and utilize natural stormwater flow runoff direction;
- Habitat restoration;
- Soil amendments designed to increase stormwater infiltration in selected locations;
- Native tree and shrub planting;
- Rain gardens;
- Bio-swales

Incorporation of these BMPs into park development will have a direct positive impact on preserving and enhancing water quality. The opportunity for education exists through the placement of interpretive signage to educate park visitors about watershed water quality and how BMPs can positively impact all sites.

The use of native plants supports the vision of enhancing the natural ecosystems at Coleman Memorial Park. The plan for the park should include shade tree planting, evergreen buffers, and shrub and herbaceous plant display beds. Native plant materials can create an attractive landscape that will help minimize long-term maintenance costs. Native plants are generally resistant to most pests and diseases. Once established, they require little or no irrigation or fertilizers. In addition to the above benefits, native plants provide food and habitat for indigenous fauna. A program for monitoring and controlling invasive plant species within the Park should be undertaken to maintain the parks native plantings. This is a labor-intensive task, ideally suited for volunteers, including school, church, or scout groups.

"Green" Material Practices

Choices in site materials have the potential to affect the health of a site ecosystem as well as the larger environment. Every material has a life cycle cost, including raw materials and natural resources, product manufactured, and delivery for use. Closer consideration of the sustainability of a materials life cycle can have far reaching benefits. Sustainable material practices include (SITES, 2014):

- Re-use of existing site materials
- Purchase of local and sustainably produced plants and materials
- Consideration of the full life cycle of materials. Consider the end life of a product. Can it be deconstructed and re-used?
- Work toward zero net waste in demolition, construction, and management

The Sustainable Site Initiative (SITES)

The SITES criteria promote sustainable land development and management practices for sites with and without buildings. SITES standards focus on site development practices and are often overlooked by "green" building standards. The SITES "system" rates projects based on management of site hydrology systems, soils, plants, material selection, and human health and wellbeing. The U.S. Green Building Council (USGBC), a SITES stakeholder, plans to incorporate SITES into future LEED requirements.

LEED

Also developed by the USGBC, the LEED program is a globally recognized, highly effective green building rating system that strives to "optimize the use of natural resources, promote regenerative and restorative strategies, maximize the positive and minimize the negative environmental and human health impacts of the building industry, and provide high quality indoor environments for building occupants".

Site Security

Crime Deterrence

Park crime deterrence is a combination of good park rules, regular policing, and proactive community participation in park stewardship. Park users are the "eyes and ears" of the Park and the "authorities" with cell phones. People who engage in negative activities do not wish to be seen and will typically go elsewhere if they are subject to observation. Park visitors should be encouraged to help the City maintain and operate proposed elements by notifying the City about issues they perceive. It is important that city and police office phone numbers and email addresses be posted at the parking areas and park access points as a part of park signage.

Random police patrols and nightly patrols should occur. The City should maintain active dialogue with neighbors and visitors to help prevent unwanted activities such as littering, vandalism, and substance abuse. Additionally, the rapid repair of damage or vandalism to park resources set a standard of stewardship that helps deter and mitigate bad behaviors.

The City may choose to install security cameras on buildings or around the park. Current security camera technology includes solar-powered and cloud-based systems, eliminating the need for wiring and onsite video storage systems.

Open sight lines should be maintained within the park. Orientation of the parking area in relation to restrooms and other park amenities should take visibility into consideration. Plant selection should also take visibility and view corridors into consideration. Trees with a high branching structure allow for strong sight lines (branches trimmed up to 7-8 feet). Lower vegetation with some transparency (loose branching structure, varied heights below eye level) will allow for visibility through plantings. Place low growing species closer to walkways, and larger shrubs and trees set back from walkways and each other. Densely growing plants should be placed away from walkway and forest edges. Placement of trees and shrubs can be adjusted to accommodate visibility needs in different areas of the site: corners and entries need a broader view corridor, and walkways feel more inviting and safer when maintained with open views of what is ahead. (Best Management Practices for Crime Prevention Through Environmental Design in Natural Landscapes, Green City Partnerships)


Maintenance / Existing Maintenance Capacity

Coleman Memorial Park is maintained by a caretaker; the exception is the city-designated roads in the park, which are maintained by the City.

The Park's design seeks to minimize landscape maintenance costs while providing a beautiful and functional park. Walkways should be regularly inspected and maintained to provide a safe user environment. Regular inspection and periodic repairs of park structures will be necessary to maintain the quality of facilities. Regular maintenance of the restroom facilities and trash removal will be required at a frequency based on the seasonal use of facilities. Restrooms should be locked at night to deter vandalism.

Mowing of lawn areas should be done on a regular basis with frequencies increasing during the growing season. This level of care deters woody plant species from establishing, while minimizing overall landscape maintenance costs, and providing habitat. Forested edges should be routinely inspected for hazards and invasives and may require periodic removal of tree hazards or invasive plant species.

Recommendations

Native Plants Garden / Rain Garden

A native plants garden is proposed for the former mini golf area, which is the first thing that visitors will see when they drive or walk into the park. Native plants are recommended over nonnative plants because they minimize long-term maintenance costs, are generally resistant to most pests and diseases, require little to no irrigation or fertilizers once established, and they provide food and habitat for indigenous fauna. Not only will this provide a sense of place in that it represents plants native to the region of Lebanon County, but it will provide a beautiful, scenic park entrance throughout the year. The plantings will include flowering understory trees, deciduous shade trees, evergreen trees, and both flowering and evergreen shrubs. It is also recommended that stormwater BMPs be added to this area in the form of rain gardens, since there is an existing swale running through the area that extends from Kreider Drive to the park entrance.

Disc Golf Course

Disc Golf is a park activity that requires minimal expense to install and maintain. This facility has the potential to attract new park users as disc golf typically draws in college age and young adults. By the time this report was completed the disc golf course had not been constructed; therefore minor adjustments to the course design may have been made in the field at the time of construction so as not to conflict with any other park uses. The new 18-hole disc golf course will be installed in 2023 or 2024 will include hole signage and easily accessible scorecards indicating course route, rules of play, etc. It will be located throughout park, beginning and ending near the main parking lot and the former Miniature Golf Course. The existing shed and concession at the former minigolf course are proposed to be repurposed to be an education/ activities center or to serve the needs of park visitors accessing the disc golf course, including those visiting for potential disc golf tournaments.

Interpretive Gardens

On both termini of the Historic Core are two former Coleman Family mansion sites—The G. Dawson Coleman "Homestead" Mansion to the west and the Horace Brock Mansion to the east. Both of these sites offer the opportunity for the creation of gardens as part of the site interpretation.

The "Homestead" site has existing mansion remnants, including portions of the former porches and driveway foundations. The porch remnants could serve as reference points for the recreation of the former mansion's building footprint as a raised curb or seat walls encompassing plant gardens that could be reflective of the mansion's interior floor spaces.

The former location of the Horace Brock mansion is within the existing parking lot, however there are remnants of the former gardens located in the lawn space east of the parking lot and west of the exit drive. Creation of a formal garden space that recalls the former gardens at this location will contribute to the site's historic interpretation.

Circulation Improvements Walking Pathway

One of the main park needs identified by the City and those who participated in the survey is walkways that are separate from the roads. The following are proposed improvements to enhance walkability within the park:

- A pathway is proposed to connect the main parking lot to the Amphitheater. There is currently an existing, unpaved path north of Bashore Drive connecting Kreider Drive and the existing tennis courts west of the pump track, but the new plan is to pave this path with asphalt and extend it to the main parking lot and Amphitheater, where it will cross Bashore Drive at the proposed pickleball courts. Pedestrian lighting is also being proposed for the length of this path, since there is a desire within the community to have movie nights and other evening events at the Amphitheater during the summer months.
- ADA access is proposed to connect Frick Drive, the Bandshell and the proposed walkway north of Bashore Drive. This will be a valuable connection, as it will provide direct pedestrian access between the playground and the concession area, which are the two primary active spaces in the park. This



connection will require an ADA ramp, which is not depicted on the plan but rather will have to be designed at a later date.

• To create better pedestrian access at the entrance of the park, a sidewalk is proposed to connect from PA Route 72 to the where the shared use trail intersects with the park road.

Park Road Improvements

The proposed road improvement is to add a two-way driveway connecting the northern and southern sections of Bashore Drive west of the main parking lot. This will be a major improvement to park vehicular circulation, as it will allow park visitors a quicker and better alternative for accessing the main parking lot. It will also provide for better recirculation within the park's one way counter-clockwise loop.

Signage and Wayfinding

The park needs improved signage and wayfinding. Many of the parks existing signs are for vehicular circulation, are dated, or list prohibited activities, and have no consistent design scheme. The new signage/ wayfinding plan that is a part of this master plan update will consolidate and simplify signage so that wayfinding is clear and succinct. The new signage system will need a consistent and attractive graphic format that will need to be designed prior to fabrication. This master plan update shows the locations and general content of the new signage system. It includes suggested wayfinding signage, restroom signage, pavilion signage, park rules and regulations signage, a dog park sign and associated DCNR funding plaque, maintenance office sign, and new accessible parking signs. For the pavilions, it is proposed that each sign show an unique historical name for the pavilion as opposed to the previous numbering system. Additionally, the City of Lebanon should explore the best locations in the city to place signage that direct people to the park.

Splash Pad and Skate Park

From the survey and public meeting, when asked what new or additional facilities should be considered for Coleman Memorial Park, 48.9% of respondents indicated that they wanted a splash pad, which was the second most popular addition after walking trails with marked distances. A splash pad in the park would be a popular water play feature for the park that would cost considerably less in maintenance and operation than the former pool. The proposed location is west of the main parking lot, which would allow for easy access to one of the sunniest locations in the park. For the future splash pad, water service will have to be provided that would be an extension of the water service currently provided to the Carriage House.

21.7% of survey participants expressed interest in a future skate park at Coleman Memorial Park. This facility would be popular among teenagers and young adults, and is also proposed west of the main parking lot for ease of access and for the sunny location. Since not many survey users are interested in having a skate park at Coleman Memorial Park, it will have to be investigated whether a skate park could better serve users at a different park within the city.

Pavilions

It is proposed that each of the pavilions in the park be designated by a sign with its own name as opposed to the current numbering system. Additionally, in terms of functional and aesthetic improvements, the pavilion between Kreider Drive and Frick Drive should have a new concrete ground plane installed for safety and ADA purposes.

Arboretum

Many of Coleman Memorial Park's significant tree specimens are located in the vicinity of the former G. Dawson Coleman "Homestead" mansion site, including the current or former Champion Gingko, and European Beech trees. This master plan recommends that a primary Arboretum space be developed on the lawn area of the south facing slope located between the "Homestead" mansion site and the park roadway (Bashore Drive) below. This Arboretum will provide plant species identification and environmental education opportunities for park users and serve as a living exhibit of the Coleman Family's love for the

natural world. Over time the arboretum space can expand as new native trees and plants are incorporated into the park.

Bocce/ Shuffleboard Courts

Bocce and Shuffleboard courts are recommended to be provided in the area to the west of the existing Pavilion #4 by the playground. These courts will provide a new park activity that is generally targeted towards older park users, but can be enjoyed by people of all ages. The relatively level ground and association with the park pavilions makes this a very good location for this activity within the park.

Bocce courts can be provided on many different surface types, but clay surfacing is the most common. Shuffleboard courts require a smooth and level surface for the proper sliding of the discs. Costs for a clay bocce surface and a concrete shuffleboard surface are provided in the Cost Estimates in Chapter 5.

Dimensions of both shuffleboard and bocce courts are similar, with the standard sizes for bocce requiring slightly more space. However, court sizes for both activities are flexible. Design of these facilities should refer to the standard sizes for each (Shuffleboard: 52'L x 10'W; Bocce 60-100'L x 10-13'W) as a starting point.

Dog Park

Dog parks are a popular community asset, and a facility that many residents are looking for as indicated by the public survey and the public meeting. At one of the flattest, sunniest points of the site, the dog park is being proposed at the former pool location and will include fenced in areas for large and small dogs respectively, as well as fenced in entry/ exit areas. To reduce overall cost, the dog park will be enclosed by both new and existing fence, the latter of which will receive a sand blast and paint treatment. The dog park will also have water fountains, which will require a water service connection. One access point to the dog park will be the existing stairs that connect to proposed parallel parking on Bashore Drive. The other access point is via a proposed ADA ramp that will connect the dog park to the concession near the bike pump track and Bashore Drive.

Pickleball Courts Conversion

Since there are two other existing tennis courts within the park, the two fenced-in tennis courts west of the pump track will be re-stripped into pickleball courts. Each tennis court can have two pickleball courts on either side of the net, so the area will have eight [8] pickleball courts in total. Removable pickleball nets are also recommended to allow players flexibility in the choice of game play.

Pickleball is a paddleball sport with elements of tennis, table tennis and badminton, and is played with two or four players. This game has increased in popularity in recent years, especially with seniors, who are often underserved when it comes to public recreational facilities.

Pickleball courts should be a rectangle 20 feet wide by 44 feet long, inclusive of 2-inch-wide lines. A total playing area 30 feet wide and 60 feet long is the minimum size that is recommended. A preferred 10-foot surrounding margin measures 40 feet by 64 feet. The net length should be at least 21 feet 9 inches extending from one post to the other (USA Pickleball Association). When over laid on the tennis courts, an 8-foot safety area should be maintained in the back of courts to conform to the 60' minimum court playing area length.

Dumpster / Trash Area

Currently the dumpsters for the park are to the south of the proposed pickleball courts and are adjacent to the existing nature trail. It is recommended that screening in the form of opaque fencing and native plants be placed around the dumpsters to shield the view from the pickleball courts and the nature trail.

Additionally, trash cans with permanent footings are recommended for placement around the park, as there are





currently no trash receptacles. The locations of the trash cans will be determined by the caretaker.

Maintenance Building

A new maintenance building is proposed for the area north of the small parking lot off of Klopp Drive. This would have an asphalt driveway connecting it to the parking lot, as well as a driveway at the back providing access from Schoff Drive. Water and electric service will have to be provided to the maintenance building, with the nearest connections for both at the restroom building east of Klopp Drive.

Basketball Courts Restroom

A two-unit restroom is proposed for the area northwest of the basketball courts across Ehrgood Drive. Since the proposed location is not near a sewer line, either a mulching/composting restroom or a 'Green Flush' toilet has been recommended, the latter of which combines the advantages of flush restrooms with the self-containment features of vault toilets. It is proposed that an electric line be run from the transformer (near the parking spaces for the John Penn Brock Gardens and Pergola) to service the restroom's electric needs.

Basketball Courts Pavilion

The two basketball courts at the west end of the park have become a popular destination for park visitors. Therefore, a 20' x 52' pavilion is proposed west of the courts, in a relatively flat area with little tree cover, which will require minimal disturbance for the construction of the pavilion. The design will be the same or similar to the existing pavilion at the pump track (see Appendix for the plans). The pavilion will be connected to Ehrgood Drive and the basketball courts by an ADA accessible asphalt path.

AED Cabinet

The inclusion of an Automated External Defibrillator (AED) cabinet in the park can play a critical role in emergency response to cardiac arrest. The inclusion of AEDs in public meeting spots is becoming more common due to the lifesaving opportunity they provide. EMTs respond to more than 300,000 cardiac

emergencies every year, and approximately 92 percent of cases do not make it. However, chances of survival increase significantly with immediate CPR and the use of an AED.

AED cabinets are self-contained units with their own power supply. Pictorial instructions are provided for proper use, and a tone or voice command alerts users when to deliver the electrical shock. AEDs are designed with failsafe protection to prevent users from shocking people who are not in cardiac arrest. AED Cabinets should be located prominently so that they can be easily identified and retrieved in an emergency. Three recommended areas for the AED Cabinets for Coleman Memorial Park are the ballfields, the pump track/ concession area, and the amphitheater.

Utility Improvements

In addition to providing electric service to the recommended restrooms near the basketball courts, the other proposed utility improvement is to connect water service to water fountains within the dog park area. In the future if the splash pad is constructed, water service will have to be provided as well.

Regional Connectivity Recommendations

As mentioned in the Inventory and Analysis chapter, the 2007 Lebanon County Comprehensive Plan proposed two greenways that would pass east-west through the City of Lebanon: the Union Canal Connector and the Quittapahilla Creek Greenway. The Union Canal Connector in particular would pass through Coleman Memorial Park via the trail connecting the park with Union Canal Tunnel Park (construction completed 2023-2024). In terms of regional connections, the construction of these two greenways could provide valuable links to the park, and the City of Lebanon in general. The City of Lebanon should therefore encourage the county to pursue the development of these trails. To aid in these developments, the City of Lebanon could even consider commissioning a Greenways and Trails Plan in order to plan for future pedestrian/ cyclist connections within and out of the city.

Priorities for Implementation

The priority for implementation is the dog park with the associated ADA ramp and parallel parking on Bashore Drive, for which the City of Lebanon applied for a grant in 2023. Other recommendations for implementation in order of priority are:

- 1. Restroom and Pavilion at existing Basketball Courts
- 2. Pickleball Court conversion
- 3. Road improvements: the addition of a two-way driveway connecting the northern and southern sections of Bashore Drive west of the main parking lot.
- Walking Pathway Improvements A: a path from the main parking lot to the amphitheater 4.
- 5. Walking Path Improvements B: a path from Frick Drive to the Bandshell to the proposed walkway on Bashore Drive
- Signage and Wayfinding Improvements 6.
- 7. Native Plants Garden
- 8. Arboretum
- 9. Interpretive Gardens

Cost Estimates

Probable costs for future development of Coleman Memorial Park were established based on unit costs from construction projects of similar scope and scale; they reflect prevailing wage rates that are required for publicly bid construction projects. The probable costs of development for the capital improvements at Coleman Memorial Park are shown in Figure 5.1. Added in the total estimated cost are design and engineering fees (estimated at 10% of the total site improvements); and a construction contingency (estimated at 10% of the total site improvements). Estimate costs are based upon March 2023 costs.

Funding Sources

There are many funding public sources that could be considered for Improvements:

Pennsylvania Department of Conservation and Natural Resources (PA DCNR)

Community Conservation Partnership Program (C2P2)

The Community Recreation and Conservation Program through the PA DCNR Community Conservation Partnership Program (C2P2) provides funding to municipalities and authorized nonprofit organizations for recreation, park, trail, and conservation projects. These include planning for feasibility studies, trail studies, conservation plans, master site development plans, and comprehensive recreation park and open space and greenway plans. In addition to planning efforts, the program provides funding for land acquisition for active or passive parks, trails and conservation purposes, and construction and rehabilitation of parks, trails, and recreation facilities. One such funding source is the Land and Water Conservation Fund (LWCF) State Assistance Program, which is a federal source of funding distributed to all states by the U.S. Department of the Interior's National Park Service. The program provides matching grants for the acquisition and development of public outdoor recreation areas and facilities. DCNR administers the LWCF Program for Pennsylvania. Most eligible projects require a 50% match, which can include a combination of cash and/or non-cash values. Grant applications for the C2P2 program are accepted annually—usually in April.

Department of Community and Economic Development (DCED)

Greenways, Trails and Recreation Program (GTRP)

The Greenways, Trails, and Recreation Program (GTRP) provides funding for: public park and recreation area projects, greenway and trail projects, and river or creek conservation projects. The program requires a 15% local cash match of the total project cost and projects must not exceed \$250,000. Applications to DCED are typically due in late May.

PennVEST (Pennsylvania Infrastructure Investment Authority)

PennVEST offers both grants and low interest loans for projects that help to manage stormwater and improve water quality. Grants are usually reserved for municipalities with lower annual operating budgets.

Legislative Funding

State and federal elected officials can sometimes include items into legislation for worthy projects in their districts. A conversation between county and municipal officials and legislators is the way to begin this process. This type of funding should be targeted toward capital improvement projects.

Private Foundations

There may be regional corporations and foundations that support public works such as park development. Competition for these funds is usually brisk, but opportunities should be researched. Funding is often given to non-profit organizations.

Foundations and institutions represent another potential source of funding for education-related site improvements and programming. Grants are available to support student field trips, provide teacher training in science, and provide other educational opportunities. Education tied to research can increase the pool of potential funds. The science community and research institutions are the logical starting points for solicitation foundation funds.

Schools and Local Organizations

Local schools and sports organizations may also be of assistance in several ways. These groups might get involved with club events, fundraising events, and park cleanup days. The school faculty might incorporate the Park into various curricula with students helping to develop and possibly maintain the Park as part of a classroom assignment or after school club. While the amount of funds raised may be relatively small, this process builds constituents and support that is critical to the long-term success of the Park.

Pennsylvania Historical & Museum Commission (PHMC)

PHMC support projects to rehabilitate, restore, and preserve historic buildings listed on the National register of Historic Places. A feasibility study/ business plan would have to be conducted to determine if any of the buildings in the park are found eligible for the National Register of Historic Places. If so, there could be some limited funding from PHMC for building renovation.

Keystone Historic Preservation Planning Grants

As established under the Keystone Recreation, Park and Conservation Fund, funding under the Keystone Historic Preservation Planning Grant program is available to nonprofit organizations and local governments for the planning and development for publicly accessible historic resources listed in or eligible for listing in the National Register of Historic Places.

The purpose of the grant is to support projects that identify, preserve, promote, and protect historic and archaeological resources of Pennsylvania for both the benefit of the public and the revitalization of communities. These guidelines address only historic preservation projects under the planning category.

Keystone Historic Preservation Construction Grants

PHMC provides funding for construction activities through its Keystone Historic Preservation Construction Grants with revenue from the Commonwealth's Keystone Recreation, Park and Conservation Fund. Funding is available to nonprofit organizations and local governments for small construction projects for publicly accessible historic resources. (Private property owners are not eligible for funding under this program and may wish to refer directly to Federal Rehabilitation Investment Tax Credit Program for information on historic tax credits.)

The purpose of the grant is to support projects that rehabilitate, restore, or preserve historic resources listed in or eligible for listing in the National Register of Historic Places. These guidelines address only construction-related activities.

Keep Pennsylvania Beautiful

Healing the Planet Grant, The GIANT Company

The Healing the Planet Grant Program, funded by the GIANT Company, aims to support water conservation efforts across The GIANT Company's operating area in the states of Pennsylvania, Maryland, West Virginia and Virginia. Applications for the 2022 grant year were accepted for \$2,500, \$5,000 and \$10,000.

Eligibility requirements for the same year were as follows: Applicants can be any tax-exempt organization located in areas where The GIANT Company operates stores within Pennsylvania, Maryland, Virginia or West Virginia . Eligible projects must be shovel ready with any required permits already secured. Eligible projects include: stream health and water quality monitoring activities, marine debris removal, storm water/MS4 education initiatives, lake/pond ecology, watershed education activities, watershed landscape measures, rain gardens, streambank restoration, erosion control, AMD remediation, rain barrels, pollution abatement and source water protection.

The Music in the Park summer program draws people from within the City of Lebanon and the surrounding area. There are even nights when the 3,500-capacity amphitheater is full. These, and other events that can be held, present ideal opportunities for the city to generate revenue, such as from hosting vendors, a wine or beer tent, food trucks, art shows, flea markets, etc.

Pavilion Rental


Renovating and advertising pavilions to be rented is another way revenue can be generated. Pavilions may be especially popular on days Coleman Memorial Park hosts special events.

Focus

• DCNR grant due April 4, 2023. Focus on funds for new restroom and new pavilion between the basketball courts and John Penn Brock Gardens and pergola

Signage/ Wayfinding

• Existing: 100+ signs in park – some negative, many confusing and dated

• Goal: simplify and clarify all signage and visitor wayfinding; make signs that have a more pleasing, natural aesthetic, similar to state park signage

Roads

- All park roads are designated City Streets
- Most are 17.5-18' wide observation: some cartway could be reduced to create space for separate loop walking paths, particularly to and from the main parking lot
- All roads are one way (parking lots are not one way)
- Existing gravel access road could be considered for public use as a means of accessing the new dog park location (former pool location). It is desirable to relocate dumpster location and/or screen within opaque fencing

Walking Paths

- Currently few designated walking paths or sidewalks people walk in the road
- Dave Funk and Joe Morales provided a suggested walking path in the master plan update mark-up (see page 6; path in blue)
 - o Includes recommendation to:
 - Close Donough Drive and Schropp Drive to vehicular traffic
 - Close Ehrgood Drive from Klopp Drive to Bashore Drive for pedestrian traffic from the parking lot to the proposed pickle ball court conversion

Sewer/ Utilities

- The 2011 master plan contained a map showing existing and proposed utilities. This was sent to Bob Sentz of COLA for any updates or revisions.
 - SC also asked if Mr. Sentz knows where the several bathroom septic fields are located

Restrooms

• See included utilities map (*page 5*) that was used in the 2011 master plan for an understanding of which toilets are on septic and which are on sewer (to be confirmed with Bob Sentz)

Disc Golf

- Mike Dunkle: designing 18-hole course (SC given pre-final plan)
 - SC will show course on master plan as an "existing condition" when holes are finalized (this is being funded by the Park Board)
 - Former miniature golf concession and storage shed buildings will be repurposed for disc golf tournaments and flexible use (arts classes, etc.)
 - Consider salvaging existing fence fabric around former mini-golf course for reuse at this park or another city site

Dog Park

- To be located at the former pool location and possibly the parcel to the south, if acquired by the City (TBD) negotiations on-going.
- To include separate areas for both large and small dogs
- City suggested precedent: Mount Joy Dog Park (Rapho Township Community Park)
- Option: keep existing fence and add to it as a means to reduce cost of installation; clear vegetation on and surrounding southern fence to create small dog park area; SC suggested to City to clear vegetation off of fence now to prevent damage to fence
- Fill in drainage basin, allow sheet flow over dog park area.
- Keep existing stairs as an access to the parking area and to facilitate the disc golf course and nature trail
- Add ADA access from Bashore Drive on north side of the dog park area and add ADA compliant walkway to connect the dog park area to the adjacent concession/ restroom
- Add head-in parking to the north side of Bayshore Drive for the length of the new dog park area.

Bike Pump Course Area

- Pavilion: kit designed by RigidPly Rafters; 20'x 52' x 8' (will use same/ similar size for proposed pavilion by John Penn Brock Gardens); Dave Funk provided SC with plans
- Option: to remove fence around the pump course concession/ restrooms fence fabric can be reused for dog park

Union Canal Park to Coleman Park Trail Connection

- Location: along the top end of the lower ballfields and switchback to the amphitheater parking lot
- Wilson Associates is engineering the trail now
- Survey recently completed as of January 2023
- Janelle will send SC plans when they are completed (although that might be after the master plan update is completed)

Additional Questions/ Comments from SC

- Why is Ergood Drive one-way west from the entrance to amphitheater parking to the "new" gravel road that turns to the right and then proceeds along Schropp Drive?
- Why is the concession/ restroom building near the pump track fenced off?
- The City may want to consider removing the old swing seats. They are not accessible and present many ways that someone could be injured.





Q3 What is your age?



Q5 Please indicate how many people of each age group currently live in your household.







Q8 Which other area parks and open space do you occasionally or regularly visit? (Check all that apply.)






